CANDIDATE CODE OF CONDUCT

Candidates for Dobson Ranch HOA Board of Directors agree to comply with this Candidate Code of Conduct (hereinafter "Code"). A copy of this Code will be given to the candidate upon his or her application for a seat on the Dobson Ranch HOA Board of Directors.

The following principles and guidelines constitute the Code:

The candidate must accept responsibility for his or her own actions and the actions of any person or persons acting and/or requested to act on his or her behalf. The candidate is required to convey the terms of this Code to those acting on his or her behalf and those persons must comply with this Code:

1. Must read, agree and sign this Code. The signed Code must be attached to the candidate's application and kept on file at the administration office located at 2719 S. Reyes, Mesa, AZ 85202.
2. May express his or her position and vision for Dobson Ranch but not demean the position and/or vision of other members of the community whether they are residents, volunteers, candidates, employees and/or a member of the Board of Directors.
3. May go house-to-house soliciting support for such candidate.
4. Must respect the resident members' right to privacy and opinion, and must leave the members' property upon request.
5. Shall not display or distribute any flyers or documents advocating support for the candidacy of any member on any Dobson Ranch bulletin board, inside any Dobson Ranch building and/or common property of the association, unless specifically at a Board of Directors' sanctioned campaign activity.
6. Shall not utilize any Dobson Ranch group activity to campaign at such gathering, unless the activity is specifically scheduled for campaigning (such as the Candidate Forum).
7. May engage residents/members **individually** to answer questions and express opinions anywhere such members are comfortable discussing the same.
